2022-23 IAABO Rules Guide

We have discovered some inaccuracies in the IAABO Rules Guide that need to be addressed. The following items need to be updated.

Page 39 Chapter 5 Segment 8 Item B

In chapter 5, there are two instances where the words “penalized” should be stated as “ignored” are incorrectly stated as follows:

- The **foul is ignored penalized** if the table crew agrees that the foul took place before the quarter or extra period ended ~~unless the foul was flagrant or intentional.~~

Page 64 Chapter 9 Segment 2 Item J

In chapter 9 there is an instance where the word “free thrower” appears twice in the same sentence. The word “free” needs to be removed as follows:

J. The ball is considered to be at a player’s disposal when any of the following occur:

- The ball is caught by a free thrower or ~~free~~ thrower, after the official bounces it to them.

Page 78 Chapter 10 Segment 4 Item A

In chapter 10 there is an instance where the word “airborne player” needs to be changed to “airborne shooter” as follows:

A. A player-control foul occurs when an airborne ~~player~~ shooter or player who is in control of the ball commits a common foul (4-19-6).

Page 92 Chapter 11 Segment 4 Item P:

In Chapter 11, the definition of a false multiple foul was inaccurate as follows:

A false multiple foul is a situation when two or more players from the same team commit personal fouls against ~~the same player from~~ the opposing team and the last foul is committed before the clock has been re-started after the first foul (4-19-12).

Page 97 Chapter 11 Segment 5 Item I:

In Chapter 11, there are two instances where the words “equal” should be stated as “unequal” as follows:

I. If there is an unequal number of bench personnel from each team who left the bench:

- a maximum of two free throws are awarded to the offended team; and
- the offended team is then awarded the ball for a designated-spot throw in at the division line, opposite the table (10-Penalties Summary-8).

Page 98 Chapter 11 Segment 5 Item L:

L. If there is an **unequal** number of bench personnel from each team who leave the bench and participate in the fight:

- Two free throws are awarded to the offended team for each additional person who leaves the bench and participates in the fight; and
- The offended team is then awarded the ball for a designated-spot throw in at the division line, opposite the table (10-Penalties Summary-8)

Page 121 Chapter 15 Segment 1 Item L

In Chapter 15, there are instances where the words “backcourt” and “frontcourt” are misstated as follows:

I. When a player has player control in the **frontcourt backcourt**, it is a violation for that player to cause the ball to go from backcourt to frontcourt and then return to backcourt, if the ball fails to contact ~~a player~~ **an opponent** in the frontcourt before it returns to backcourt, and if they or a teammate are the first to contact the ball in the backcourt.

- This could occur if a player **in the backcourt** avoids a defender by making a bounce pass with spin on it so the ball bounces in the ~~backcourt~~ **frontcourt** and spins back to a teammate in the ~~frontcourt~~ **backcourt**.
